Introduction to the Europe-China Strategic Cooperation and Development Forum

The Europe-China Strategic Cooperation and Development Forum will be a large-scale economic and business cooperation forum organized and hosted by the United Financial Services Group (UFS). The forum will be held on 30th-31st October 2010 in Beijing, PR China. Approximately 100 European and Chinese mayors, as well as 500 financiers, entrepreneurs, media representatives and scholars are expected to attend, give a speech and engage in discussion. Speakers will come from European and Chinese government officials, ambassadors and leaders of European and Chinese enterprises and institutions.

The Europe-China Strategic Cooperation and Development Forum will be held annually, its goal to provide ample opportunities to promote cooperation between Europe and China and to facilitate the realization of existing possibilities and emphasize chances for development
